## ORDER-IN-APPEAL

This appeal has been filed by the Superintendent of Police, Himmatnagar, Police Head Quarter, Idar Road, Himmatnahar, Gujarat [hereinafter referred to as "appellant"] against Order-in-Original passed by the Additional Commissioner, erstwhile Central Excise Commissionerate, Gandhinagar. The details are as under:

- The appellant have opted for "Sabka Vishwas (Legacy Dispute Resolution) Scheme, 2019 [for 2. short-SVLDRS] on 21.12.2019 for the issue under appeal and the designated committee has now accepted their application under SVLDRS and issued discharge certificate to them in terms of provisions of Section 127 of the Finance Act, 2019.
- I find that as per provisions of Section 127 (6) of the Finance Act, 2019, in respect of a declaration filed under SVLDRS which is accepted by the designated committee and issued discharge certificate, the appeal before appellate authorities challenging the issue/tax dues for which settlement is sought under SVLDRS, will be deemed to have been withdrawn. The relevant provisions of Section 127 (6) of the Finance Act, 2019 is as under:
  - "(6) Where the declarant has filed an appeal or reference or a reply to the show cause notice against any order or notice giving rise to the tax dues, before the appellate forum, other than the Supreme Court or the High Court, then, notwithstanding anything contained in any other provisions of any law for the time being in force, such appeal or reference or reply shall be deemed to have been withdrawn. "

In view thereof, the appeal under consideration is to be considered as withdrawn. Accordingly, I 5. dismiss the appeal as withdrawn.
