- 2. The financial up-gradation under the MACP Scheme granted to the above officers is subject to inter-alia, the following conditions:-
- (i):On grant of financial up-gradation, there shall be no change in the designation, classification or higher status. However, financial and other benefits which are linked to the pay drawn by an employee such as HBA, allotment of Government accommodation shall be permitted.
- (ii) The benefit of pay fixation available at the time of regular promotion shall also be allowed at the time of financial up-gradation under the MACP Scheme. Therefore, one increment shall be given in the Level from which the employee(s) promoted in financial up-gradation granted and she/he shall be placed at a Cell equal to the figure so arrived at in the Level of the Rost to which promoted I financial up-gradation granted and if no such Cell is available in the Level to which

Promoted Phinancial up-producing granted, she the shall be placed at the next higher Coll in that

- (iii) With regard to Frantion of pay on grant of promotion / financial up-gradation under MACP Scheme, beneficiary has an option under FR 22 (b)(a)(d) to get her / his pay fixed in the higher Post / Grade pay either from the date of her? his promotion / up- gradation or from the date of her/his next increment vizz 1st July / Ist January of the year. The pay and the date of increment would be fixed in accordance with the Depth of Expenditure's Q. M. No. [4]/2008-IC dated 13.09/2008 and [DoPT Q. M. No. 13/02/2017-Ust] (Pay-b) dated 27.07,2017 and subsequent chrification issued thereafter
 - (iv) The MACP Scheme contemplates increty placement on personal busis in the immediate higher Level of Ath CPC pay matrix / grant of financial benefits only and shall not amount to actual / functional promotion of the employees concerned.
 - (v), Financial Up-gradation under the MAGP Scheme shall be purely personal to the employee and shall also have no relevance to his semonly position. As such, there shall be no additional financial up-gradation for the senior employee on the ground that the junior employees in the grade have got higher pay under the MACP Scheme.
 - (vi) The Pay drawn in the pay Scale (Pay Level) and Grade Pay/Level in 7th CPC Pay Matrix allowed under the MACE Scheme shall be taken as the basis for determining the terminal benefit in respect of the retiting employee.
 - (vii)) The grant of tinancial up-gradation to aforementioned officers under MACP Scheme may be changed I withdrawn consequent upon receipt of any clarification and it it as founds inadmissible for any reason.
 - 3. The Concern D.D.O. shall check and ensure corredness of the due date of smarcial up gradation allowed, from the service records of the officers before allowing benefit of financial Up-gradation. Discrepancy noticed, it any should be prought to the notice of this office.
